



## ***10 Hour OSHA Safety and Health Outreach Training Program***

### **NEW:**

**Effective 07/08**, the NYS Department of Labor (Local law 20) requires that for every public work construction contract (state agencies, municipalities, school districts) valued at more than \$250,000 that all on-site laborers, workers, and mechanics employees in the performance of the contract be certified prior to performing any work on the project, as having successfully completed the **OSHA 10-hr construction safety and health course**.

**Effective 7/09**, under LL 41 of 2008, prior to performing any work, all workers at "major buildings" (as defined by 2008 Building Code) are required to have completed a 10-HR OSHA construction safety course within the previous 5 years. Impacted workers required to complete the training include all active trade workers as well as managers, foremen, and project superintendents working on the project site.

The OSHA Construction Outreach Training Program is a voluntary training program intended to assist individuals in recognizing, comprehending and complying with federal OSHA requirements. TSC offers the 10-Hour OSHA Construction Outreach Training Programs, in-house or on-site, utilizing the latest teaching techniques and audio visual aids to deliver needed information to workers and supervisors in a professional and informative manner.

This training is intended to provide an initial and basic overview of key OSHA Construction Industry Standards. It is important to remember that the content of this course shall provide only the basics on Construction safety and is intended for both the worker and novice safety professional. The content of the training is flexible, permitting TSC to individually tailor training programs to suit any organizations industry-related, site-specific safety-needs. The benefits of the outreach training are immediate for both employee and employer and include increased workplace safety awareness and compliance.

### **Course Completion Materials**

Participants are required to attend all class sessions to receive a completion certificate and OSHA completion card. Completion certificate will be issued at the conclusion of training program. Participants who successfully complete the course will receive a laminated 10-hour OSHA card within 4-6 weeks after conclusion of class directly issued by OSHA.

- Health Hazards in Construction (including Hazard Communication)
