



32-Hour Erector/Dismantler Supported Scaffold Safety Training Program

Local law passed in May 2005 and enforced as of November 2006...

Scaffolding is widely used during construction and renovation activities. In its simplest form, a scaffold is any temporary elevated or suspended work surface used to support workers and/or materials. There are many types of scaffolds, both supported and suspended.

*“**Supported scaffold**” shall be defined as one or more platforms supported by outrigger beams, brackets, poles, legs, uprights, posts, frames, or similar rigid support **forty feet in height** or more and including, but not limited to, sidewalk bridge scaffolds, single pole scaffolds, tube and coupler scaffolds, fabricated frame scaffolds, tubular welded frame scaffolds, outrigger scaffolds, needle beam scaffolds, mobile scaffolds, repair bracket scaffolds, mast climber scaffolds that are mechanized or motorized, back structures for personnel hoists and/or material hoists and system scaffolds*

TSC’s 32-Hour Erector/Dismantler Supported Scaffold Safety Training Program is in compliance with the training requirements of Subchapter 2 of chapter 1 of title 26 of the administrative code of the city of NY. The training is typically provided in four, eight-hour class sessions, however TSC is aware of the time sensitive needs of today’s Construction Professional and will work with your organization to design the most suitable schedule possible. With evening class sessions available, one can fulfill work obligations by day and receive start of the art training by night. The scheduled programs are held at our convenient Long Island City Location at 5 Court Square-across from the Citibank Building. Walk to NYC transit, LIRR, easy access to Queens Midtown Tunnel, 59th Street Bridge and LIC, with plenty of nearby parking options.

WHO SHOULD ATTEND?

*Any person who **erects, dismantles, repairs, maintains or modifies** any supported scaffold over 40 feet must complete a training program of at least **thirty two - hours** and be issued a supported scaffold user certificate verifying completion of the program. An eight-hour scaffold safety and training refresher program or course must be completed **four years**.*
